Why use the historical fundraising tool?

Using the historical fundraising tool on Infrastructure Online will help you to easily identify key fundraising trends in a year or quarter, as well as providing a quick filtering tool for historical fundraising by geographic focus or fund manager location.

Step 1: Access the Historical Fundraising Tool


Access the **Historical Fundraising** feature through the **Funds** module on **Infrastructure Online**.

This feature allows you to easily access and download details of funds closed over a certain time period, with a chart displaying historical fundraising according to the selected criteria.



Step 2: Select Your Criteria


To amend the criteria utilized, select 'Amend Search Criteria,' apply the relevant filters and click 'Search.'



Step 3: View Your Results

Once the criteria have been selected, the results page will alter to display the historical fundraising results by year or quarter. Selecting the Excel logo at the top left of the chart will download the chart results to Excel.

To view details of individual funds closed in the time period selected, click on any year or quarter shown in the left hand column of the table.

Acciona Energía International	Acciona Energía International (AEI) is the international renewable energy generation business of Accion Energía, the Spanish multinational's energy division. Most of the portfolio is comprised of wind farms, with a small number of solar (photovoltaic and thermal) assets. In October 2014, KKR Infrastructure Fur acquired a 33.33% stake in Acciona Energía International (AEI) following a €397mn investment, with Acciona retaining a two-thirds interest.	
Belwind	Belwind is a 330MW offshore wind power facility located approximately 50km off the Belgian coast; it includes 55 wind turbines and provides green energy to over 350,000 homes. In October 2014, Sumitomo Corporation acquired a 39% stake in the Belwind Wind Farm from their wholly owned subsidiary Colruyt Group. The project cost was estimated at €650mn.	
EDPR France	EDPR France is a unit of EDP Renováveis and operates in the field of renewable energy. EDPR France is based in Paris and specializes in wind power, operating a portfolio of over 30 French wind farms totalling over 330MW in total output. In October 2014, <u>EFG Hermes</u> , through its private equity arm, completed a \$208mn transaction to acquire a 49% stake in EDPR France.	

Infrastructure Deals - Asset Profile Moyobamba - Iquitos Transmission Line Moyobamba - Iquitos Transmission Line is a 220-kilovolt, 390 mile, transmission line linking the north-central city of Moyobamba with the remote Amazon city of Iquitos in Peru. In October 2014, Grupo Isolux Corsán acquired a 100% stake in the asset in a deal worth \$500mn. Click here to log in and view this profile.

Adiant Renewable Opportunities	Adiant Capital Partners	Adiant Renewable Opportunities (ARO) is targeting €250mn to invest in a diversified portfolio of renewable energy infrastructure projects, primarily in the wind power and solar photovoltaic sectors, as well as other sectors on a selected basis. ARO focuses on Germany, France and the UK, although other investments are also considered to support diversification.			
UBS International Infrastructure Fund II	UBS Infrastructure Asset Management	UBS International Infrastructure Fund II invests on a long-term basis in a diversified portfolio of core infrastructure assets located in OECD countries only. The investments of Fund II predominantly consist of brownfield operational assets, with up to 30% of its capital invested in greenfield infrastructure projects. The fund targets \$1.5bn for opportunities in the energy, utilities, transportation and water sectors, as well as social infrastructure projects.			
Brazil Mezzanine Infrastructure Fund II	Darby Overseas Investments	Brazil Mezzanine Infrastructure Fund II is a joint venture between Darby Overseas Investments and Stratus Investimentos, and provides mezzanine financing to small and mid-market infrastructure-related companies in Brazil. The vehicle is targeting \$300mn to directly invest in and manage Brazilian infrastructure companies and projects. Brazil Mezzanine Infrastructure Fund II provides investors with a broad infrastructure portfolio by targeting a range of economic sectors.			

Featured Fund Closed



Macquarie Infrastructure Partners III (MIP III) reached a final close in September 2014 having raised a considerable \$3bn. The fund, managed by Macquarie Infrastructure and Real Assets (MIRA), is an unlisted vehicle aiming to earn direct and indirect income through infrastructure assets and infrastructure-related businesses. MIP III is a closed-ended vehicle primarily investing in assets located in the US and Canada, with the option to invest in Mexico.

First State Super	Australian superannuation scheme First State Super will be making new investments in infrastructure in the next 12 months via direct investments and unlisted funds, with a total of AUD 2.5bn allocated for this purpose. Geographically, the superannuation scheme will target OECD countries, though it can also invest up to 20% of this capital commitment in non-OECD countries. First State Super is open to investing in greenfield and brownfield assets in core infrastructure sectors.		
Korean Re	South Korea-based insurance company Korean Re will be making new commitments to private infrastructure funds in the next 12 months. In terms of geographical location, the insurance company will target fund opportunities in its domestic market; however, it will also be open to investing in developed countries across the globe. Korean Re has a preference for funds targeting prime assets.		
Pensionskassernes Administration	Denmark-based asset manager PKA has a yearly target of \$800mn (€590mn) for private equity, infrastructure and energy fund commitments. In addition to fund commitments, PKA will also consider further direct infrastructure investments over the next 12 months, investing around \$2bn in direct infrastructure. PKA has a global infrastructure mandate and typically targets developed markets.
